Feedback Needed: Alternate Assessment Redesign

This spring, MDE began exploring options to redesign the MTAS as we develop the next series of alternate assessments aligned to new science standards. MDE is looking at several potential changes, including test design, scoring, number of questions, types of questions, reporting needs, and administration format.

At this important step in the redesign process, MDE is seeking feedback from district staff who are involved in the many aspects of the alternate assessment (MTAS) administration. These staff may include special education teachers familiar with instruction for students with significant cognitive disabilities, DACs, administrators, or special education directors.

MDE is seeking feedback in either (or both) of the following ways:

- An <u>Alternate Assessment (MTAS) Redesign Survey</u>, which takes about 10 minutes to complete and is available through July 10.

2020–21 Technology Releases and Resource Updates

The following resources are now available in <u>WIDA AMS</u> under My Applications > General Information > Technology Downloads:

- Installers for the COS-SD and INSIGHT Secure Browser applications
- Testing Site Capacity Estimator

Technology documents for the 2020–21 academic year have been posted to the <u>Technology Coordinators Page of the WIDA Secure Portal</u> [log in required] and in <u>WIDA AMS</u> under My Applications > General Information > Documents. Note the following key changes:

- The Supported System Requirements for ACCESS and WIDA Screener, July 2020—October 2020 has a
 revised format and methodology. DRC has not changed the system specification for either the testing
 devices or the COS Service Devices in the 2020—21 academic year. Districts and schools do not need to
 purchase new hardware to meet the specifications.
- Technology Coordinators should be sure to allow three additional URLs for this year's online testing. These new URLs are in the System Requirements and Testing Information section of the *Technology User Guide*.
