2020 Extended ACCESS Testing Window Important Dates

For districts participating in the extended ACCESS testing window, the following table provides the important dates for this administration.

Test Administration Window	Aug. 3–Sept. 25
Deadline to Ship Materials Back to DRC	Oct. 1

Keep in mind that the extended spring 2020 testing window for ACCESS is being provided as an option **only** for English learners (ELs) who would have been eligible to exit a Language Instruction Educational Program (LIEP) based on previous scores and/or their other completed domain scores this past spring – **not** all ELs who were unable to complete testing last spring. The decision to participate in this extended testing window is determined by the district. Testing must be in-person and cannot be administered remotely. **Participating districts must order materials by Sept. 1.**

Final Reports Delivery and Resources

Individual Student Reports (ISRs) for both MCA/MTAS and ACCESS/Alternate ACCESS are scheduled to arrive in districts tomorrow, Aug. 20. (Note: For MCA/MTAS, a few districts may not receive their reports until Friday, Aug. 21.)

- ISRs for ACCESS/Alternate ACCESS will be provided for all students who participated in ACCESS/Alternate ACCESS.
- ISRs for MCA/MTAS will be provided only for students with a valid score in at least one subject.

Since ISRs contain private student data, **it is important for districts (that will be receiving an ISR shipment) to ensure someone is available to receive the reports and secure them until distribution**. Refer to last week's *Assessment Update* for detailed information about this shipment.

Final Results in Vendor Systems

Electronic copies of ISRs and other final results will also be available in the applicable vendor systems tomorrow, Aug. 20.

- For ACCESS and Alternate ACCESS, electronic copies of ISRs and rosters will be available in WIDA AMS. Translated versions of ISRs can be downloaded in WIDA AMS, as needed. Note: For 2020, no district or school frequency reports will be available in WIDA AMS.
- For MCA and MTAS, electronic copies of ISRs will be available in PearsonAccess Next under Published Reports. These ISRs are available by grade and subject (by school) or in a zipped file of individual results separated by student (by district and school). Note: Users will need software such WinZip, WinRAR, 7-Zip, etc. to open the zipped file.
 - For 2020, rosters, benchmark reports, and longitudinal reports will not be available.
 - Longitudinal exports and historical student data will be available, but the data is limited.

Test Specifications Development Committee: Alternate MCA

MDE is looking for diverse group of K–12 special education, reading, and science educators to use their expertise to develop test specifications for the Alternate MCA (previously MTAS) in science and reading. The Alternate MCA is the redesigned alternate assessment aligned to alternate achievement standards designed for students with the most significant cognitive disabilities.

The purpose of the committee is to decrease the depth, breadth, and complexity of the science and reading standards on the Alternate MCA by developing assessment boundaries and access points for students with the most significant cognitive disabilities. The committee will meet virtually throughout the 2020–21 school year.
