## Reimbursements for College Entrance Exams

Last week, MDE issued reimbursements to districts based on the requests made (by the Sept. 11 deadline) in the Graduation Requirements Records (GRR) system for eligible students who took a qualifying college entrance

exam (ACT or SAT). The payment was identified with "ACT/SAT REIM," followed by the date, and a unique number (e.g. 0000039). The payment also contained the explanation of GRR-REIMBURSEMENT.

## 2020-21 College Entrance Exam Requirement

As in past years, districts are required to offer a nationally recognized college entrance exam (ACT or SAT) to grade 11 and 12 students during a 2020–2021 school day. Districts must enter into a contract directly with the test vendor. Core requirements for offering a college entrance exam have not changed and are detailed in the 2019–20 Procedures Manual; see page 31. See below for more information about ACT and College Board.

#### **ACT**

- View administration information, Free/Reduced Lunch Program (FRLP) pricing structure, and key testing dates and deadlines on the ACT District Testing page.
- Districts will need to provide ACT the percentage of students that are eligible for free or reduced-priced meals to determine if the district will get a reduced price from ACT.

# SIS and Data Warehouse Vendors: Scheduled Extracts (repeat)

For the spring 2021 test administrations, Student Information System (SIS) and data warehouse vendors will have the opportunity to receive regularly scheduled extracts of preliminary on-demand test result data for the MCA and MTAS during the testing window and/or final data extracts for MCA/MTAS and ACCESS/Alternate ACCESS following the release of the DSR/SSR files.

As of Wednesday, Sept. 23, at noon, Pearson has received a commitment to use the extracts from the following vendors:

#### **WIDA Webinar**

On Sept. 29, MDE's Statewide Student Assessment and Data Analytics Division will host a virtual conference for DACs. This event will feature a "State of the Statewide Assessment" presentation by division director, Jennifer Dugan. Participants can connect to the audio of the event using their computer/device, or they can call into the event using a phone. Note: Those that use a phone may consider downloading the Cisco WebEx smartphone app. Using the smartphone app will provide an easier connection to the event and will allow for more functionality than using the dial-in phone number. #### **Teaching and Learning Led by Evidence Webinar Series**

This series of webinars is for any teacher or school leader who wants to center instruction on evidence of student learning. Kendra Olsen, MDE's Outreach Specialist in Statewide Student Assessment and Data Analytics, will facilitate each session to engage teachers and school leaders in making sense of assessment and data, so that it can be used to build trust and collaboration and develop fluency in decision making to help close gaps in instruction and learning.
