## Procedures Manual for 2020–21 and Related Documents

The 2020–21 Procedures Manual for the Minnesota Assessments will be posted by Friday, Oct. 2, on the Policies and Procedures page of PearsonAccess Next. Chapters and certain topics have been reorganized in this year's Procedures Manual to better reflect the order in which a DAC is likely to need the information. Chapter 1, along with the typical overview of what is new, will include a table that provides a quick reference of these organizational changes.

Note: The 2019–20 version of the *Procedures Manual* is currently available, and it will be replaced when the 2020–21 version is posted.

The updated versions of the *District Test Security Procedure Template* and *Guidelines for Administration of Accommodations* will also be posted by Oct. 2 on the <u>Policies and Procedures page</u>.

### **District Test Security Procedure Template**

Additions to the list for 2020–21 District Test Security Procedure Template include:

- Determining a process for documenting reasons why students may not be participating in testing (e.g., parent/guardian refusals, medical excuse) and communicating this information to applicable school staff
- Determining a process for how information will be communicated to applicable school staff to ensure that students take the correct assessment (e.g., MCA or MTAS; ACCESS or Alternate ACCESS) and/or receive the general supports, linguistic supports, and/or accommodations required

Districts can use the sample district test security procedure template available on PearsonAccess Next or create their own procedure. However, MDE strongly recommends using the template in order to ensure all requirements are addressed completely. Districts that have used the template receive fewer recommended changes during MDE's review of their test security procedures.

### **Guidelines for Administration of Accommodations**

The Guidelines for Administration of Accommodations (formerly known as Guidelines for Administration of Accommodations and Linguistic Support) provides information for the administration of the MCA with a scribe, mathematics/science script, and signed interpretation. The applicable guidelines should be provided to Test Monitors administering these accommodations for review prior to testing.

Note: Changes to the guidelines are called out within the document.

## **Virtual New DAC Orientation: Registration**

MDE and Pearson will provide a virtual New DAC Orientation. In the past, this orientation was provided as an inperson, full-day session. For this year, in order to provide the best training experience for participants, the New DAC Orientation will be a virtual event spread across three days for a few hours each day, and each session will cover different topics. MDE recommends that DACs attend the live sessions, if possible, as they will include interactive information sharing as well as time to discuss topics with colleagues. However, the presentation will be recorded for each day's sessions if participants are unable to attend the sessions live. **Note: DACs should sign up for all three sessions, as each session will provide different information.** 

MDE will provide an overview of the various roles and responsibilities of a DAC, the Minnesota Assessments, relevant MDE and WIDA systems, available resources, and training opportunities. Pearson will provide information on PearsonAccess Next, TestNav, reporting resources, and the Training Management System. Though designed as an introduction for new DACs in their first or second year, other relatively new DACs are also welcome to attend.
